## Fédération des Coopératives du Nouveau-Québec

The Fédération des coopératives du Nouveau-Québec (FCNQ), is the majority shareholder of TTI. FCNQ was founded on May 20, 1967 and to this date, has over 7200 Inuit members in Nunavik exclusively. The FCNQ is owned by an organization of fourteen co-ops in the Inuit community, located along the coast of Hudson Bay and Ungava in Nouveau Québec (Nunavik). The profits generated by FCNQ, including profits generated by TTI, are distributed among its members and the direct or indirect profits are invested to benefit the local economic development in Nunavik.

The cooperative movement is, today, the largest non-governmental employer in the region, with more than 260 full-time employees and 50 seasonal employees in Nunavik, as well as 120 full-time employees based in Montreal. The co-ops are managed by the Inuit and Cree personnel, therefore insuring and maintaining the experience that has been acquired in their community.

Since 1967, co-ops have been founded in all Inuit villages of Nunavik and the strength of the corporate movement enables the Inuit to partake in their own development.
